General Comments and Suggestions:

Ironton is a community with a rich heritage rebounding from an era that did not prepare them for what they have experienced. Instead of lying down and giving up, Ironton is determined to recreate its image while not forgetting the rich heritage and the hard work that preceded this generation.

The judges feel that in such a short time, Ironton is well on its way to bringing the community into a new future. The simple addition of incorporating floral displays has set the tone for future achievements. Congratulations to the mayor and the community for wanting to improve your and your children's way of life. We thank the city of Ironton for its genuine hospitality during our visit. Carol Allen is a treasure for your community and is responsible for moving forward with Ironton's beautification efforts.

The Ironton-Lawrence County Community Action Organization was created in 1975 and is anchored at the John Campbell Memorial Home. By pooling resources and following one agenda, Ironton can become a "Must See Location." The judges suggest that all future projects within the city be reviewed by the commission so that future projects will be in harmony with one another.

With all the renovations scheduled, please keep in mind that the number one question to ask when an architect is starting a renovation project downtown is, "How old are the brick paver streets?" Then follow up with the second question, "How old is the infrastructure below street level?" Sewer, water, gas, electric, and communications can be installed in the sidewalk area, causing minimal damage to the original brick paver streets.

Consider searching out young painters who would be up to the challenge of re-painting the riverside levy wall to mirror the downtown buildings behind it.

Also consider some shrubs or perennials to spell out IRONTON between the river and the levy wall.

The media coverage that Ironton receives is priceless. Great job in having press opportunities and thank you to the media for printing Ironton's stories.

Suggestions are indicated in italics.

Ironton has stepped up to the plate to revitalize the community. Uniform codes were developed and accepted by the citizens to make the city sparkle. Ironton has proven that leading by example works! Great job! While the downtown business district revitalization plan is developing, keep in mind that you could create a great "Walking Flow" for all residents and visitors to navigate.

The judges suggest you create recycle/rubbish containers to be properly distributed. The judges also suggest that more "Pedestrian Rest Areas" be provided in the downtown area.

The addition of the street sweeper and the citywide schedule for it is spectacular.

The judges suggest that the Public Works Dept send an inspector around the city, especially in the downtown area, to look for items in need of repair, such as broken electric sockets at the base of light poles. These are potential hazards for children.

The same inspector can look for low trees that need trimming and branches that block stop signs. Reviewing the landscape architect's plan prior to final approval can avoid these issues.

The street signs are of different styles, heights, and locations throughout the city. Consider going down river to Aurora, Indiana, to review the new 3M street signs in Victorian borders. Consider adopting something similar

Partnering with the ILCO Solid Waste Department, the City of Ironton sponsored a clean up

week to remove tons of unwanted or abandoned items.

Commercial

The Main Street Project has given Ironton new life.

Many businesses both in and out of the main street area joined with Ironton In Bloom to beautify the city.

The judges suggest that the current businesses act as a committee to finalize a list of the types of other businesses will complement the "New Ironton."

Some of the alleyways are littered with debris near the containers. The judges suggest that tall enough foliage be planted as a screen to all these areas.

Residential

Over 200 volunteers participated in the 9th Annual Volunteer Day to clean up and prepare the city for the "grand opening" of the new floral display containers. You did a great job.

The residential areas are neat and trim. The judges believe that because of this, you should create a seasonal "Tour of Neighborhoods."

The judges believe that you could also focus on updating the original underground infrastructure with the streetscape planning.

Encouraging a company to set up shop in Ironton and manufacture wind turbine devices in one of the vacant factories could make Ironton the American center of the newest technology.

Classes could be given to understand the positives of recycling household waste and yard waste.

The LSSWD district provides anti-litter and environmental training to local school children.

Commercial

The clean-up and re-use of the commercial "Brown Fields" is commendable

Local businesses dispose of hazardous wastes responsibly through the LSSWD clean up drive.

Use of LED year round lighting to the historic downtown rooftop structures could enhance the attractive architecture and the entire revitalization effort.

Use of more recycle containers would be a plus in the downtown business center.

The LSSWD is partnering with a local store to develop a program to accept old analog TVs when the broadcasting signals change in 2009.

This way, you can accommodate multiple venues at the same time, two areas can be based in the downtown area and two others on opposite ends of the city.

The city supports dozens of community organizations that all create a higher quality of life for the residents.

The judges suggest that all the Service Groups get together and create fundraising calendars for the next year using the gathering spaces.

Commercial

The commercial businesses support the city. They are to be commended for their generous contributions to the Ironton in Bloom initiative.

Several Family Fun Days throughout the year and two musical events sponsored by commercial businesses bring a sense of community to Ironton's residents.

The Liebert Corporation has donated generously to projects that include the school system, renovation of Tanks Stadium, and many community growth and improvement projects.

The judges suggest that when a function does occupy downtown, that you stay open for business. Try opening later that day.

Residential

There are many active service groups, church groups and volunteers that play a vital role in the community with their support of numerous programs.

The Master Gardeners organized a Plant Exchange Day that was a huge success with residents.

Assistance is given to seniors and disabled with their gardening and property maintenance needs. The judges suggest that tall planting beds be created for the seniors to garden easier.

Encourage the young citizens to create and manage future projects. "Today's Youth are Tomorrows Leaders!"

Ironton is a historic gem. From the civil war pig iron to current projects, the downtown renovations have brought the city back to life. Many structures are on the historic registry. This history is documented at the Hamner Room at Briggs Public Library, the County Museum in the Colonel George N. Gray Home, through the National Historic Registry, and is lived daily by the residents.

The city has taken many actions to preserve and promote many historic preservation initiatives.

The city planned, applied for funding, contracted with an historic consultant service, and sponsored programs that provide both architectural design services and cost sharing for downtown building owners to undertake downtown façade improvements, with the goal of being designated in the National Historic Register.

The city is commended for the renovation project in progress on the Ro-Na Theater.

The judges suggest a multitude of "Pocket Programs" created by different groups to have as fundraisers monthly. This will create tourism.

The judges suggest that the person answering the phone in the tourism office be the one appointed to attend the Bus Tour Convention. They are the voice that tour operators and visitors associate with. They can be your best Ironton Cheerleader at these types of events.

mercial

community is lucky to have a commercial sector that is active in restoration and velopment projects. The projects are too numerous to mention individually, but when pleted will be a joy for all.

downtown commercial district looks as if it was still back in the early 40's. The foundation is there, so only do slight alterations to keep them that way. The challenge now is to find our apancy.

The judges suggest that you call Eureka Springs, Arkansas to work with artists to enjoy many of the downtown structures as a second home.

Residential

The walking tours of residential areas and other historic structures are great. Congratulations!

There is a wealth of wonderful architecture in the homes built during the boomtown days. Homeowners are commended for maintaining these historic structures beautifully.

The judges encourage the residents to renovate additional period homes.

The judges recommend that homeowners renovating period homes use recycled materials stripped from other dismantled period homes.

The City of Ironton partners with the Ironton in Bloom committee to ensure the proper planting of urban street trees and shrubs throughout the downtown business district.

The judges suggest not having trees block store fronts, street lights or traffic signals.

The judges suggest planting more mature trees like a Green Pillar Oak.

With the help of Ann Bonner, Urban Forester, an Inner City Tree Planting recommendation list was created. The city with the assistance of the ODNR Forestry Division's Inner City Tree Planting Grant planted an additional 84 trees in the downtown business district and 30 forsythia bushes along the riverfront. An inventory of these plantings was created. We recommend making a complete vegetation inventory for the city. This could possibly be done through the use of university interns. Contact Greendale, Wisconsin or Echo, Oregon to save steps in accomplishing this.

Creating a plan to incorporate a certain percentage of trees to any new project is suggested. A plan to revitalize the tree canopy is advised.

We recommend exploring how to become a Tree City USA City.

We commend Mayor Rich Blankenship for supporting tree maintenance and planting policies. A seminar could be conducted to show homeowners the proper planting and pruning procedures so trees, when mature, are not in the way of utilities.

We recommend the addition of a qualified arborist to the city team.

Commercial

The judges suggest a business initiative to donate and plant a tree in the residential areas. This will foster good will and support from the residents.

Residential

Most of the mature tree canopy that the judges observed shaded the power lines and not the homes..

Homeowners are encouraged to plant trees that will provide energy usage reduction.

The City of Ironton is applauded for integrating landscaping into its streetscape system.

Many landscape projects have been started to improve the downtown area. Coordinating future projects to be consistent within a master landscape plan or guidelines, will make all future projects more successful.

The ordinances in force are not specific to help the city when going out to bid for revitalization projects. Until you organize the ordinance, ask the following questions before giving anyone the "Go ahead" on any project. When an architect offers a style of streetlight, ask the question of "How will the light be disbursed?" When they place the lights ask, "How will the mature trees affect the light?" When they want to place trees or lights ask," How will that affect the entrance to the business in front of it?" and finally ask "If you are going to plant trees, why can't you use a species that grows upright quickly OR plant a mature tree?"

Conduct classes for residents on the proper planting procedures for landscaping and flower beds.

Native plantings could be planned for all areas near the Levy wall areas.

Commercial

The commercial businesses are applauded for adding their own pots and hangers to complement the IIB floral display initiative, to compensate for not having a natural area that can be landscaped.

While entering the downtown sector, the judges noticed the effort to create landscaped areas in front of some locations. Landscaping does not mean turf & trees. The addition of the flower pots is landscaping.

The judges suggest that all businesses look at ways to landscape around the flower pots in their area and create a balanced display or pedestrian rest area.

Churches and schools have organized several landscape improvement projects.

Residential

Residents take pride in their landscaped areas.

The Plant Exchange Day enables residents to bring and trade plantings for landscaping purposes.

The Yard of the Month program recognizes residents for their landscape improvement efforts. This has motivated many residents to make improvements. Congratulations for a successful program.

The mayor could possibly extend the Yard of the Month program to have a winner in each Ward every month to keep the program rolling.

Attend classes on proper planting procedures.
